

## MEMBERSHIP TYPES

Each member level (except Business) comes with voting privilege and covers you and a co-member within the same household for 1 year from the date paid. All members receive The POGLA Post (weekly email,) News You Can Use, free Coffee Shop and online meetings, and event discounts.

**\$50- Basic** Members at this level recognize the need to participate as an active manager of their oil and gas rights.

**\$150 - Full Partner** At this level, a member makes a fair-share contribution to the cost of legislative action to support fair oil and gas laws in Pennsylvania. This level also includes access to special invitation-only events.

**\$500 - Sustaining Member** For those members that support our purpose and want to set POGLA up for success in our mission to promote fair oil and gas legislation in Pennsylvania. It includes all of the above benefits and special invitation-only events.

**Group Memberships: \$150+ Full Partner Group or \$500+ Sustaining Group** The group level membership is for a family, club or group entity who want to manage multiple members with group-level billing. Individual members within a family or group have voting rights and receive all of the benefits of Full Partner or Sustaining membership. Add children, siblings, heirs, club members, partners, etc. as additional members at a price of \$50 each.

**\$300 - Business Membership** This non-voting organizational membership allows a business to include up to three individuals in a packaged membership. Additional employees may be added at a cost of \$100 per employee. Includes a sponsor ad on POGLA's website, as well as vendor, sponsor and advertising discounts for special events.
